'Are you going to arrest him again?' HC to ED on plea seeking cancellation of CM's bail

4 get 7 years in prison for shooting at cops

EXPRESS NEWS SERVICE NEW DELHI, AUGUST 7 THE DELHI High Court on Wednesday briefly took up a plea by the Enforcement Directorate (ED), seeking the

cancellation of Chief Minister Arvind Kejriwal's bail. Questioning what remained in its challenge now that the Supreme Court has granted him interim bail, the High Court asked the ED, "Are you going to arrest him again?"

Taken up before the court of Justice Neena Bansal Krishna, ED emphasised before the judge that Kejriwal's arrest has not been declared illegal and requested for an adjournment as Additional Solicitor General (ASG) SV Raju will be arguing the case. Meanwhile, Kejriwal's advocate and senior counsel Vikram Chaudhary opposed the request for adjournment, saying, "This is sheer persecution... he should then argue the matter, not seek adjournment."

Earlier this month, the HC had dismissed Kejriwal's plea challenging his arrest by the CBI and also disposed of his bail plea but granted him liberty to move the trial court for the relief. The court pronounced that the CBI's arrest of Kejriwal "cannot be said to be without justifiable reasons or as illegal".

Gurgaon: A court here on Wednesday sentenced four people to seven years in prison for shooting at a police team in 2021 and injuring two policemen. Two of those convicted also suffered injuries in retaliatory firing by police in a gunfight that broke out after a car chase in 2021. The court of additional district and sessions judge Tarun Singal also imposed fines on the perpetrators. PTI

Elderly couple killed, son injured as roof of their house collapses in Prem Nagar

A MAN and his wife died while their son was injured as the roof of their house collapsed in Prem Nagar's Kirari in the early hours of Wednesday, police said.

At 2.57 am, a PCR call was received at the Prem Nagar police station, officials said, that the roof of the house collapsed, and three people were trapped. According to the police, upon reaching the spot, Sukhram, 85, his wife Gayatri, 75, and their son Vinod were all taken to the Sanjay Gandhi Memorial Hospital, Mangolpuri. Sukhram and Gayatri were pronounced dead upon arrival by the doctors, police said. Vinod, 40, was discharged after treatment.

"Preliminary inquiry revealed that the house was old and the roof collapsed suddenly at night while the three were inside. No foul play into the incident has been found," DCP Rohini, Gurbal Singh Sidhu said. The bodies of the deceased have been handed over to the family after post-mortem and necessary legal action would be taken into the matter, he said.

A few days back, a three-month-old child died after the roof of a house collapsed in Tughlakabad Village. In another incident, a man died after a chunk of marble, from the roof of Digambar Jain temple in Gandhi Nagar, fell on his head.
