Cabinet nod to Rs 30k subsidy for 3 kW rooftop solar panels

THE DELHI Cabinet on Tuesday approved providing Rs 30,000 subsidy on the installation of 3 kW rooftop solar panels (Rs 10,000 per kW) under the PM Surya Ghar scheme -- the world's largest domestic rooftop solar initiative -- increasing the total subsidy available to Rs 1.08 lakh.

The Delhi government has introduced 'PM Surya Ghar: Muft Bijli Yojana State Top-Up' scheme to enhance the effectiveness and reach of the initiative. Under the PM Surya Ghar scheme, the Centre provides Rs 78,000 subsidy for installing rooftop solar panels.

The BJP government has allocated Rs 50 crore to install rooftop solar systems on 2.3 lakh residential units over the next three years.

Chief Minister Rekha Gupta stressed that the new subsidy allows consumers to access solar power solutions at zero initial cost while saving Rs 4,200 on their monthly electricity bills on average. She added that the government is partnering with financial institutions to offer easy loan options for the remaining installation cost of around Rs 90,000.

To control pollution, the government approved a sanitation and dust control plan proposed by

PWD. Under this, advanced cleaning machines will be procured for use on PWD roads. These included 250 water sprinkler machines integrated with anti-smog guns, 70 mechanical road sweeping machines integrated with 210 water sprinkler machines and anti-smog guns, 18 dump vehicles, and 18 water tankers.

These machines are expected to be fully operational before the onset of winter, said the CM Office

in a statement. Gupta added that the Environment Department will provide the necessary budget to the PWD for the deployment of the machines. These machines will be used exclusively for dust cleaning on roads and can be deployed across Delhi as needed, the statement further said.

Also, the Cabinet approved the proposal of the Directorate of Education to reinstate the name of the scheme, namely 'Lal

Bahadur Shastri Scholarship for Meritorious Students,' in place of 'Chief Minister Scholarship for Meritorious Students'. In 2019-20, the scheme was discontinued and restructured under a new name by the previous AAP government.

Under the scheme, government school students from classes 7 to 12, who have secured 80% or more marks in the previous academic year, are awarded a scholarship of Rs 2,500 per annum.

DDA launches new housing scheme, open to all

THE DELHI Development Authority (DDA) on Tuesday launched a new housing scheme, under which 7,500 flats would come up for sale at Narela, Loknayak Puram, and Siraspur.

The scheme, 'DDA Apna Ghar Awaas Yojana 2025', was launched by Lieutenant Governor V K Saxena. The DDA is offering these flats at a discount ranging from 15%-25%. Also, anyone above the age of 18 can buy these flats on a first-come-first-serve basis, the agency said in a statement.

Two DDA housing schemes launched earlier this year -- DDA Sabka Ghar Awaas Yojana and

DDA Shramik Awaas Yojana -- had offered flats at a discounted rate for only certain sections, such as construction workers and autorickshaw drivers, among others. In Siraspur, 564 low income

group (LIG) flats will be built, with each flat costing between Rs 13.3 lakh and Rs 13.6 lakh.

In Loknayak Puram, 150 LIG flats will come up, with each flat costing between Rs 20.24 lakh

and Rs 21.35 lakh. Also, 96 middle income group (MIG) flats are to come up at Loknayak Puram, each to cost between Rs 1 crore and Rs 1.04 crore.

In Narela, Economically Weaker Sections (EWS), LIG and MIG, even High Income Group (HIG) flats will come up, each costing between Rs 10 lakh and Rs 1.47 crore. While bookings under the scheme will begin on May 25, it will close on August 26.

Demand for DDA flats at Narela has picked up, the agency said. Developments like the Cabinet approving the Rithala-Narela-Kund corridor of Delhi Metro, and universities planning to set up campuses, "have played a catalytic role in making Narela a preferred choice of buyers", it added.

Man falls asleep while cooking inside bus, dies

Noida: A 45-year-old bus driver was charred to death after he allegedly dozed off while cooking inside a bus early Tuesday, the Noida Chief Fire Officer said.

The police identified the deceased as Ram Naresh, a resident of Uttar Pradesh's Mainpuri. The incident occurred at Transport Nagar in Sector 69.

Noida Chief Fire Officer Pradeep Kumar said, "Prima facie it looks that the man was cooking on the dashboard inside the bus... he dozed off while cooking, leading to bus catching fire." Since the helper of the bus was sleeping on the roof, he managed to survive, Kumar added. **ENS**

BJP MLA proposes installation of Malviya and Savarkar portraits in Assembly gallery

BJP MLA and party's chief whip Abhay Verma on Tuesday proposed that portraits of leaders such as Vinayak Damodar Savarkar, Dayanand Saraswati and Madan Mohan Malviya be put up in the Delhi Assembly gallery.

The proposal was submitted

to Assembly Speaker Vijender Gupta. "The proposal has been forwarded to the General Purposes Committee of the Assembly as per procedure. A decision will be taken on the proposal on Wednesday," an official said.

Verma, the Laxmi Nagar MLA, said that the move is meant to commemorate the country's "glorious past" and inspire the

younger generations. "This will not only express our devotion and gratitude towards the nation but also instil the Vidhan Sabha with a lively historical awakening," Verma said in his letter to Gupta.

Earlier, this year, AAP MLAs had alleged that the portraits of B R Ambedkar and Bhagat Singh were removed from the Assembly after the BJP came to power. The allegation was rejected by BJP.

BSP leader, family killed in 2017: Absconding business partner held

AMAN, who was arrested in connection with the murders of a BSP leader and his family in 2017, and jumped parole last year, was arrested again on Monday.

The accused, Saheed Khan, was a business partner of Chaudhary Munawwar Hassan, a local BSP leader in Burari, for years. Police said he knew Hassan owned properties worth Rs 5-6 crore in the area and coveted them.

In 2017, Hassan was arrested in a rape case and was serving his sentence in Tihar Jail. Police said Khan used the time to win the trust of Hassan's family.

When Hassan's wife, Ishrat, told Khan that she urgently needed to visit family in Meerut, Khan decided to act. He hired two contract killers.

On April 20, 2017, Ishrat (40) and her two daughters, Arju (19) and Arshi (15), were shot and killed. Their bodies would later be discovered by the police, buried in a field near Meerut by the side of the highway.

Two days later, Khan allegedly

strangled Hassan's sons, Aaqib (20) and Shakib (16), and buried their bodies in one of Hassan's properties in Burari.

Back at the jail, Hassan grew suspicious when his family stopped visiting him. When he asked Khan, he would tell him that his family had not been seen for many days.

Worried, Hassan applied for bail to find his family. Khan accompanied Hassan on May 18, 2017, to the Burari police station to help him file a missing persons complaint. Two days later, Hassan was found dead, with a gunshot wound, in the bathroom of his Burari residence.

Police said it was Khan who made the call, informing them of the leader's death. As they began investigating the murder, police said Khan kept changing his statements. When they questioned him further, police said he admitted to orchestrating the killings with the help of contract killers -- Feroz and Zulfiqar. He and his accomplices were arrested and sent to Tihar Jail.

In September last year, Khan, who was still an undertrial prisoner, was granted parole on per-

sonal grounds, with a directive to return to custody in October. However, he absconded, prompting the issuance of non-bailable warrants, said police.

"As a team of the Special Staff was earlier involved in uncovering the conspiracy behind the brutal murders committed in 2017, former investigating officers were contacted and relevant details collected. Technical surveillance was also mounted, and the residences of the accused and his associates were identified. We received information that Khan would be visiting his residence to collect some money. Subsequently, a trap was laid near his residence, and he was successfully apprehended," said DCP (North) Raja Banthia.

During questioning, police said Khan admitted that he had been hiding in areas around Burari to evade the police. He has now been handed over to the Burari police station, said police.

Khan had been booked in two cases from 2017 under IPC sections 302 (murder), 120B (criminal conspiracy), 363 (kidnapping), 365 (abduction) and 34 (common intention) along with sections 25 and 27 of the Arms Act.
