महोदय,

As you are aware, the first unit of Khurja STPP (1320 MW) and its dedicated transmission line from Khurja to Aligarh commenced commercial operations on 26.01.2025. In accordance with the CERC Tariff Regulations, 2024, THDCIL has submitted tariffs for Khurja STPP and the associated Transmission line for the period 2024-29 to the Honble CERC. Enclosed herewith are the audited tariff forms submitted alongwith petition for your reference.

With the commencement of commercial operations and the tariff petition filed, THDCIL has prepared energy bills for MAY-25. These bills have been prepared, taking into account: (i) CERC (Terms & Conditions of Tariff), Regulations, 2024, (ii) Provisional REA dtd 02-JUN-2025 issued by NRPC, Amendment-I of MEA issued by UPSLDC dtd. 10.06.2025 and (iii) Audited Tariff Forms for AFC submitted to the Honble CERC.

Furthermore, we would like to inform you that 90% of the AFCs for FY 2025-26 for Khurja STPP and the Dedicated Transmission Lines have been considered for the preparation of these bills. They include Capacity Charge, Energy Charge, Supplementary Energy Charge, Transmission Charge, NRLDC Charge (For JAN-25 to APR-25), Energy Incentive (APR-25 and MAY-25) and Revision Bills for the month of APR-25 for Energy Charge and Supplementary Energy Charges based on Revised Fuel Data Forms (Form 15A, 15B & 16).
