

2. ORGANIZATION PROFILE

THDC India Limited (formerly known as Tehri Hydro Development Corporation Ltd.), is a Joint Venture of Govt. of India and Govt. of Uttar Pradesh. The Equity is shared in the ratio of 75:25 between GoI and GoUP for the Power Component. The Company was incorporated in July" 88 to develop, operate & maintain the 2400 MW Tehri Hydro Power Complex (comprising of 1000 MW Tehri Dam & HPP, 1000 MW Tehri Pumped Storage Plant & 400 MW Koteshwar HEP) and other hydro projects. The Company has an authorized share capital of Rs. 4000 cr. THDCIL is a Mini Ratna Category-I and Schedule "A" CPSE.

The Memorandum and Articles of Association of the Company has been modified to reflect the current business reality of projects outside Bhagirathi valley. The object clause has been amended to incorporate development of Conventional/Non-conventional/Renewable sources of Energy and River Valley Projects.

The Corporation has grown into a multi-Project Organization, with Projects spread over various States as well as neighbouring Country, Bhutan.

THDCIL is consistently profit making company since the commissioning of Tehri Dam & HPP in the year 2006-07. THDCIL is a dividend paying company since 2007-08.

Tehri Dam has been conferred the Prestigious award of "International Milestone Project" by International Commission of Large Dam (ICOLD) in October, 2009 at China, considering the uniqueness of its design and construction features. Koteshwar HEP has been conferred the PMI India Best Project Award of the year in long term duration (More than 3 years) category in 2011-12. THDCIL has been conferred the Power Line Award in the category of 'Best Performing Generation Company (in Hydro Sector)' in May, 2012. THDCIL has been conferred SCOPE Meritorious Award for Corporate Social Responsibility and Responsiveness in April, 2012.

3. CSR & SUSTAINABILITY POLICY

The CSR & Sustainability policy 2015 has been redrafted covering provisions of company act and rules thereof including all amendments issues till 22 September 2015 and DPE guidelines. The draft CSR and sustainable policy 2015 was considered by the board level CSR committee and recommended board for approval. The board approved the draft CSR and Sustainable Policy 2015 as recommended by the Board Level CSR Committee (BLC).

During the financial year 2016-17 the company has incurred CSR expenditure of Rs 1534.85 Lac as earmarked for implementation of CSR activities. The unspent amounts during the year are carried forward to the next year.

Every year, THDCIL, with the approval of its Board of Directors will make a nonlapsable budgetary allocation for CSR and Sustainability activities/projects.

CSR and Sustainability Programmes of the Company are steered through Below Board Level (BBLC) & Board Level (BLC) CSR Committees.

CSR works of company have been entrusted to company sponsored NGO i.e. SEWA-THDC. CSR budget has been utilized mostly in the vicinity of THDCIL's various project locations /business area as per the Companies Act 2013 and DPE guidelines on CSR & Sustainability 2014 effective from 1st April 2014. The major thrust areas during current financial year were health & sanitation, art and culture, promoting education, vocational skills & livelihood projects, women empowerment, environmental sustainability & ecological balance, rural development of backward district Tehri. Overall it has been ensured to have inclusive growth and up-liftment of the marginalized and under-privileged sections of the society.

8. THDC Educational Society (TES):

There are two schools running under the auspices of THDC Educational Society (TES) - one at Bhagirathipuram, Tehri offering education from 6th to 12th standards and another school at Pragatipuram, Rishikesh offering education from 1st to 10th standards. In both the schools, children of nearby areas belonging to the economically weaker sections including backward and SC/ST are being provided quality education.

During the year, many initiatives have been taken up to improve the quality of education. Experienced Principals with army/central school background are ensuring effective superintendence and administration. Extracurricular activities are organized from time to time like summer camps, excursions tours etc. The students are trained for cultural programmes and national festivals. The initiatives taken by the TES have resulted in increase in the strength of students in both the schools, at Tehri and Rishikesh. Teachers are being provided training from time to time to improve their skills.

For the year 2016-17, Total Rupee 480.00 lac were allocated and was the expenditure noted for TES.

9.1 THDC JAGRITI (Education)

Jagriti generally means awakening or vigilance, is of Indian origin, name Jagriti is a part of "**THDC Sahridaya'** and a mission for educating the project affect people in various operational areas. The programs spectrum ranges to professional courses, vocational courses, and any short term courses including the support to the educational institutes.

9.2 Society Managed by THDC Education Society (Inter College and High School)

Inter college Bpuram and high school at Rishikesh at present pursue the "UTTARAKHAND BOARD "Pattern of education. At the end of the academic year 2016-17 there were more than 600 students studying in both schools from class 1 to class 12 .These students were guided by the learned and qualified teachers and supporting staff headed by the principal. Every students receives the following facilities

- a. Two pairs of school uniform
- b. Text books
- c. Note books and stationary items
- d. College Bag
- e. Free transport from place of residence to school and back

- All the fifty students are fully sponsored for tuition fee including lodging and boarding etc.
- The budget for the program was Rs. 7 lakh.

9.4 Higher Technical Training Program for the students of ITI Chamba

The project was implemented to impart technical knowledge to the ITI candidates through organising training workshops at AKGEC Ghaziabad. This project was executed under the CSR-SD activities of the THDC during financial year 2016-17.

- The total budget of the programme was Rs. 5 lakh.
- It was ensured that this training programme will enable students of ITI Chamba to seek job opportunity in technical sector.
- This project has played significant role in the skill enhancement of the participants.

9.5 ITI Training program for youth

• One programme was to provide training for the trade of Fitter, Copa, welder and electronics. The program was fully sponsored including tuition fee, lodging and boarding etc. This program was implemented to impart knowledge and enhance technical skills of the students to earn livelihood.

- Another program was aimed to provide facility of education and training to 12 students to enable them to accomplish Diploma course in Industrial Training Institute
- The estimated budget of the project was Rs. 8, 46,000

9.6 Diploma in HM course for 2 candidates of Gram Asena, Bhilangana Block Chamba Tehri

- The Hotel Management programme has been conducted at Tehari Institute of Management Education (TIME). This programme was designed to provide two candidates of Gram ASENA with Diploma in Hotel Management from TIME.
- The duration of diploma was for one and half year
- The budget of the project amounted to be Rs. 1, 05,000 which includes uniform, study material and hostel fees.
- The project also provided six months of industrial training at star graded hotel.

9.7 Construction tin shade at Ucchatar Madamka Vidyalaya Chamiyala Ghansali

- The project was implemented to provide construction of tin sheds in primary school CHAMIYALA.
- The project was budgeted for Rs.6,00,000.

9.8 National Symposium at Dehra Dun

Project at a Glance: NASI, Uttrakhand Chapter and Uttrakhand State Council for Science and Technology (UCOST) Dehra Dun has organized 86th Annual Session for National Symposium on "Science Technology and Entrepreneurship for Human Welfare in the Himalayan Region" on 02-12-2016 to 04-12-2016 at UCOST Dehra Dun.

Benefit of the Project:

This programme was successfully undertaken which was directly beneficial to the research community academicians .There were almost 400 researchers have participated. Some of the implementing agencies were benefited by the symposium.



9.2 THDC PRAKARTI (Environment)

Conserving environment for better living and life for all is another thematic area of THDCIL and is being propagated and implemented by means of

- Awareness and sensitivity to the environment and environmental challenges
- Knowledge and understanding of the environment and environmental challenges
- **Attitudes** of concern for the environment and motivation to improve or maintain environmental quality
- **Skills** to identify and help resolve environmental challenges
- **Participation** in activities that lead to the resolution of environmental challenges
 - The initiatives taken in the current financial year are

1. Cleanliness Awareness Programme under Swachh Bharat Abhiyaan

THDCIL corporate organize a cleaning program where it made people aware about the various activities that helps to clean environment.



Main objectives of the program were

- To eliminate the garbage and polluted items and understand the environment duties and responsibilities.
- Selected schools were taken, where teachers, students, In-charges, mess workers, staff members etc. were made aware of cleanliness.

2. Supply and installation of 214 solar lights is Tehri and Haridwar (white LED based)

The installation of the Solar Street Lights have been undertaken in Tehri and Haridwar under CSR Funding by SEWA-THDC Unit. The Target of 214 solar lights has been achieved during this project. Implementing agency also conducted programmes for spreading awareness about importance of solar lights for sustainable development.

3. National workshop on Challenges in irrigation management for edible security

The national workshop was organized in which training and awareness event has been undertaken focussing on the challenges in irrigation management. This programme targeted Research Groups & implementing agency. It helped to secure edible security with the help of teaching about "How to increase the irrigation facilities and performed a various duties" that increased the irrigation management and made them aware about the resources. This workshop was organized at the Indian Institute of Technology IIT Roorkee.

4. National workshop at 86 annual session of National science academy

National workshop at 86 annual session of National science academy held on 27/9/2016 by UTTARAKHAND state council for science and technology (UCOST) & UTTARAKHAND technical university (UTU). National symposium is being organized in an effort to meet holistic approach to the needs of agricultural sector, entrepreneurship and new technology.

5. Maintenance of herbal nursery lawn and plants planted at various places in THDCIL:

Environment Department maintains Herbal nursery, lawn & plants planted at various places THDCIL campus RISHIKESH and various horticulture works are done for maintenance of trees/ fruit plants and medicinal plant like ALOVERA.

6. Organization of KISHAN GOSTHI and plantation work at REHAB area TEHRI

- THDC'S INDIA LTD's social departments organized the KISHAN GHOSTI workshop to provide information to the farmers and to make them independent.
- The program was basically concerned to provide information regarding organic farming, dairy udyog, mixed farming, poly house, mushroom farming, cycle farming, land improvement and development.





9.3 THDC SAMARTH (WOMEN Empowerment)

Women Empowerment is to increasing and improving the social, economic, political and legal strength of the women, to ensure equal-right to women, and to make them confident enough to claim their rights, such as freely live their life with a sense of self-worth, respect and dignity, have complete control of their life, both within and outside of their home and workplace, to make their own choices and decisions, have equal rights to participate in social, religious and public activities, have equal social status in the society, have equal rights for social and economic justice, determine financial and economic choices, get equal opportunity for education, get equal employment opportunity without any gender bias, get safe and comfortable working environment etc. THDCIL has taken some key initiatives towards few of them such as

1. Skill Development for self-empowerment

Various initiatives are undertaken for women empowerment such as Silai Kadai, Self Help Group formation and driving them for income generation, Agriculture education, Farming and better techniques for higher productivity and income etc.


- To provide skills development and training.
- To promote income through vegetable production and Non-farming activities.



2. Deepa Mai Mahila Credit Cooperative Society (District TEHRI):-

SEWA-THDC started a new initiative for women empowerment though micro finance. The Society is uniquely designed on a model where in women are majority board member of the society and will put together their seed money as an investment and in return can receive lending five times of the money they deposit any time. SEWA THDC has proposed to deposit rupee five lacs to start the scheme and also some members of the society has undergone a training programs and a field visit to Pant Nagar university to understand the Agriculture and livelihood projects.





9.4 THDC NIRMAYA (Health and Sanitation)

Adequate sanitation, together with good hygiene and safe water, are fundamental to good health and to social and economic development. Open defecation remains a persistent and pervasive problem across the country. It is particularly acute in rural areas where there is a lack of awareness regarding the causality between open defecation and health related issues, especially of diarrhoeal diseases which are a major cause of child mortality in India. THDCIL has taken it up as one of the priority area and the activities taken for the year are

1. Deen Gaon Health center

SEWA THDC is running a health centre at Deen Gaon with the help of Karori Mal College, Delhi University. Over 1000 patients per month form nearby villages are receiving free medical services through daily OPD and emergency services. The centre is managed by a professional MBBS experienced doctor supported by medical staff. The centre is equipped with an ambulance, dispensary, Digital X-ray machine etc.

2. Homeopathy dispensary

Total 04 Homeopathy dispensary at POKHRI, DHONTARY, KOTESHWAR and RISHIKESH from April 2016 to March 2017 approx. 54797 patients of 04 homeopath centres of several cases were checked, treated and medicines were provide free of cost. The project was budgeted for Rs. 17, 62,440.

The Health Centre established at Koteshwarpuram (Block-Narendranagar) in Tehri Garhwal in the beginning of March 2014. The Health Centre is also being managed by Swami Narayan Mission Society (SNMS) through its dedicated and selfless mind. The public and patients belong to the villages Kyari, Siroli, Dobhal-Goan, Bandaria, Payal-Goan, Jakholi-Saundiya Goan, Sauni, Alli-Talli, Khand-Surkhet, CISF & allied staff and some of THDC-staff and officers are being benefitted regularly with the great contribution of SEWA-THDC. Since April 2016 to March 2017, **15256** patients of different cases were checked, treated and provided medicines free of cost in the O.P.D. of Koteshwar,. Medicines for almost all kinds of diseases are provided.





1. Organizing 06 multispecialty medical camp at project affected area TEHRI & PIPALKOTI

Skill development program is taken up inline with the government of India National Skill mission program. Skills and knowledge are the driving forces of economic growth and social development for any country and towards this aim DAKSH program is launched to address the fulfilment towards this need. The programs for the year are

1. Cutting Training Programme in Dehradun Rishikesh:

- The project was implemented to impart skills related to stitching, beautician, and earning livelihood for women.
- The duration of program was 6 months
- According to this project 90 women was trained



2. Computer Training Programme in Dhontary Block Dunda

- The project was implemented to impart computer training to youths
- Provided free computer training to 40 educated youth.

The duration of the project was 6 month

3. Skill Development Training Programme for 20 Youth of Tehri:

• The project was implemented to provided skills and livelihood to 20 educated youth.

• The 70% people were supposed to get employment after the completion of training. The duration of project was 32-35 days.

4. Six Month Computer Training Program At Khurja:

- The project was implemented providing computer training to the youth.
- The duration of the project was six months.
- The forty educated youth getting benefit by this computer training.

5. Jute, Makrm, beautician training program at Rishikesh

Four batches of six months Jute Training Program, Makram Training Program, tailoring training program and Beautician Training Program were organized at Rishikesh for local needy and minority women. 100 women registered for All Trainings in which 72 women have got benefitted this training program which 36 women benefitted from Jute, Makram, Cutting Tailoring Training Program and 37 women got benefitted from Beautician Training Program. It was seen that some of women opened her own shop of tailoring and some are engaged with garments factory and boutique showrooms. Women who have got Beautician training are engaged with beauty parlous business thru salary basis and own beauty care shop and they feel proud and happy as they have become capable to earn some money for their livelihood. Some of the women have started their tailoring and beauty care shop in their area and getting approx. `4000 – 9000 per month that has added to the economic growth of their family income and improve her family living standard.

It is recorded total 194 Kg Mushroom was produced and 176 kgs. Oyster (Dingri) mushroom sale by women in local villages i.e. Khola. Jalwal Gaon, Badeel, Gandoli, Rindol and local market Madannegi and Rajakhet and main market New Tehri.

The whole group earn net profit of Rs. 35,200/- from sale of White Oyster Mushroom. Women farmer is enable to explore new opportunity to establish Mushroom Units and generate income through this new avenue.

- 2. Now women are ready to install large scale commercial Mushroom units.






