Project at a Glance:-

In our country more than 70% population are living in villages and the condition of the villages are not too good in respect of basic commodity/needs such as health sector & education sector etc. Generally it has seen that the people are not aware about health & hygiene and benefit of education. If the health of the person is good they feel active & strong. Health is wealth, proves very right as healthy people can try even hard work to earn their livelihood.

Geographical condition of villages of Uttarakhand is remote and very time taking for seeking urban benefits for survival of human beings as most of the villages are far away from approach roads. A single dispensary is seen around the area of 4 to 5 villages, and even doctors are not available. After construction of Tehri Dam, some area of block Pratapnagar, Bhilangna and Jakhnidhar have been submerged.

In view of above, SEWA-THDC has decided to open a homeopathic dispensary at Galiyakhet through Swami Narayan Mission Society, Shisham Jhari, Muni Ki Reti, Rishikesh so that nearby areas of PAF can get medical facilities.

Benefits from the Project:-

As a feedback it is seen that, generally people are trust in homeopathic medical treatment in villages.

A homeopathic doctor having BHMS degree was appointed during the project and approx. 3200 persons were benefited from this project. It was also found that chronic diseases were also cured during the period.

PAPs of the area are feeling happy and requested SEWA-THDC to continue with the said homeopathic medical centre.
