## **Project at a Glance**

District Magistrate, Chamoli, Uttarakhand had requested THDCIL for assistance of Rs. 6.10 Lacs for installation of 10 Nos of Water Purifiers / ROs along the Pilgrimage Route of NH-58. The Purpose of the project/ assistance was to provide Clean Drinking Water to the Pilgrims during Yatra season.

On sanctioning of the project by THDCIL, an amount of Rs. 6.10 lacs. was released to DM, Chamoli, Gopeshwar in April, 2012. Administration had further issued orders in this regard to Executive Engineer, Jal Sansthan, Chamoli for installation of 10 No. Water Purifiers / RO Systems as below:

1. 04 locations under Joshimath Tehsil
2. 03 Locations at Chamoli Tehsil and
3. 03 under Karan Prayag Tehsil.

The Water Purifiers / RO Systems have been installed on NH-58 adjacent to Police Stations or DGBR Office in order to prevent the systems against any theft or damage. The Electrical connections to units have been provided from the respective Police Stations/DGBR Office.

DM has further instructed the concerned Police Thanas / Department to be wholly responsible for the protection & safety of Water Purifiers / RO Systems so installed. However, the repair and maintenance shall be taken care of by Executive Engineer, Jal Sansthan, Chamoli.

## **Benefit accrued from the Project**

During the visit of THDC site officials in the month of Oct-13 it has been noticed that all units exist at the locations indicated under DM's letter and units are functional. The Water Purifiers / RO Systems cater the Drinking water needs among pilgrims visiting Shri Badrinath Temple, Hem Kund Sahib etc.
