#### **Project at a Glance**

Education is a fundamental right of every citizen granted by the Article 21 A of the Constitution. This has got a perfect shape in the form of Right to Education Act 2009. Education plays a very important role in shaping the future of a country. Assuming the responsibility of providing education to the children belonging to nearby villages, Project affected area, THDCIL as its Corporate Social Responsibility is running a school at Koteshwar Project site since 2014 with the help of private institutions.

#### **Implementation**

There was an agreement in force till the academic year 2014 under which the Drona International School, Dehradun was given the task of running the school. After the expiry of the agreement with Drona International School, Dehradun, a new agency i.e. Omkaranand Saraswati Public School, Education Society, Dev Prayag was assigned the task of running, managing and administering the school in Koteshwarpuram initially for a period of one year till the new society is registered.

New society registered is named as **Swami Omkarananda Saraswati Public School Samiti Koteshwar**. In the year 2014-15, the school was run by the Omkaranand Saraswati Public School, Education Society, Dev Prayag and then onwards a new society registered, was managing the school with the new name of school "**Swami Omkarananda Saraswati Public School Koteshwar**".

#### **Facilities Provided**

This newly registered society in now taking care of all day to day activities of the school. The school at present pursues the CBSE pattern of education and has

applied for its recognition from the state government. It is expected that by last of

quarter of year 2016 the school shall be recognized by the Uttrakhand State Government. At the end of the academic year 2015-16 there were 130 students studying in the school from Nursery class to Class VIII. These students were guided by a team of qualified teaching staff and supporting staff headed by the Principal.

THDCIL has provided necessary infrastructure to run the school free of cost which includes class rooms equipped with furniture, Computer, stationeries, chalks, photocopier, library, telephone etc and other basic amenities includes safe and clean drinking water, toilet facilities and play ground. The school staff is provided accommodation at nominal rate by THDCIL. A school bus has been arranged by THDCIL for commuting students from their villages to school and back. Students are provided books by SEWA-THDC under CSR free of Cost.

### **Benefits from the Project**

The school is providing quality education to the students of the nearby area and most of the students belong to economically weaker section of society. The fee charged per month amounts to Rs. 300.00 per student and weaker section students are taught free of cost. The financial gap between the fee collected from the students and financial implication on account of salary to the staff and other miscellaneous expenditure is being borne from CSR budget.

From time to time on various occasions in order to encourage students to develop their extra as well as co-curricular skills THDCIL organizes various competition and the participation from the students is encouraging. Students also participate regularly on all the national festival and functions organized by THDCIL. Students are provided dress for participating in various day to day functions organized by THDCIL.

From time to time surprise inspections by Koteshwar Management are carried out in order to check the quality of education being provided to students. Continuous efforts are being put to improve the quality of education and turn this school into an institution of standard class prevalent in the state. The Koteshwar Hydro Project Management is committed towards leaving no stone unturned in ensuring that the children in the nearby villages get what they deserve. Being a Mini Ratna Company THDCIL views, providing education as a great responsibility and has been trying to ensure the same with the help of SEWA-THDC.
