CIRCULAR

Sub: Computation of amount of Contribution required to be transferred from EPF to EPS or deposited to EPS under Employee Pension Scheme, 1995 for implementing Hon'ble Supreme Court Judgement dated- 04/11/2022.

In pursuance to Hon'ble Supreme Court Judgement dated- 04.11.2022 on the Employee Pension Scheme , 1995 and subsequent circular dated- 16.01.2023 issued by THDCIL HR Department, the eligible existing and retired employees shall be required to contribute @ 8.33% on the actual salary along with the interest of balance amount for availing of the benefit enhanced pension under EPS,95. Pending claraity/modalitities/circular/guidelines etc from EPFO, a tentative computation has been done based on historical data of individual employees considering monthwise simple interest based on prevailing interest rate of EPF.

Considering the inadequate time for depositing the balance amount on actual salary, the historical salary data of individual employees have been collected/derived based on actual amount of EPS already paid and determined simple rate of interest of EPF on balance amount thereon. The data of each eligible employees /ex employees have been uploaded to the individual account at FMS portal.

The remittance of requisite contribution with enhance pension benefits thereon shall be subject to acceptance of EPFO as per Rules and in case of any higher contribution is required by EPFO, the same shall be deducted from the account of THDCIL EPF Trust or deposited by the employees.

Employees are required to check and verify the data and intimate changes, if any, before 10th Feb,2023 by providing documentary proof to Sh. Kirti Arora, Dy. Manager (Finance) for revision of the same.
