



Empanelled hospital providing credit facility shall send the bill along with the supporting documents to the P&A Deptt. of the concerned Unit from where the patient is referred for admission. The unit will arrange the payment of credit bills to the Hospital within a period of 30 days from the date of receipt of the bill. No credit facility will be available for OPD treatment.
