Dear sir,

Govt. of Uttarakhand vide its G.O.NO.1325/XXVIII-I/20-01/(19)2020 (Medical Health & Medical Education, Section-1), Dehradun Dated: 02 September, 2020 (**Copy Attached**) has circulated following rates for treatment of COVID-19 infected patients by private NABH/NON-NABH hospitals located in State of Uttarakhand:

Notwithstanding above, G.O. referred to above further elaborates conditions as detailed below to be taken into consideration by above private hospitals located in State of Uttarakhand and empanelled with THDC India Ltd. while raising IPD credit bills for payment against COVID-19 treatment of THDCIL employees:

1. The empaneled hospitals will charge 80% of above stipulated rates against COVID-19 treatment charges.
2. Above rates will be applied under following terms & conditions:
 - a) Treatment of all COVID-19 infected THDCIL employees will be carried out as per the guidelines issued by Govt. of India / ICMR.
 - b) The facilities like bed, food, monitoring, nursing, doctors visit/consultancy, tests including imaging, treatment & co-morbidity as per national protocol for COVID care, standard care for oxygen, blood instrumentation etc. will be included in the above package rates of private hospitals.
 - c) The health issues like High Blood Pressure, Diabetics, heart related problems etc., the charges accrued on treatment of such co-morbid health issues of the COVID-19 patient will be a part of above rates package.
