

The Contractor within Twenty-Eight (28) days after receipt of Letter of Award (LOA)/Purchase Order and prior to signing of contract agreement, shall be required to submit performance security through RTGS/ NEFT Fund Transfer to THDCIL account or an irrevocable Contract Performance Guarantee (CPG) towards faithful performance of the Contract for three percent (3%) of the Contract Price (including GST) i.e. **Rs.3,28,189.00 (Rupees Three Lakhs Twenty Eight Thousand One Hundred Eighty Nine only)** in the form prescribed in the bid document.
